Parent Permission to Share Contact Information and Allow the Use of Child Images

Overview: Amazing Life Games Preschool uses online technology as our primary way to communicate with families. We share stories and photos from the classroom, pass on helpful resources, write about our educational approach on our blog and more. ALG uses a listserv (at amazing-life-games@googlegroups.com), a Facebook page, a Blogspot and Google web albums. In an attempt to use less paper, Amazing Life Games also shares our family rosters electronically. We rely heavily on these technologies (both text and images) to share information with families and build the ALG community.

Child Images: Any pictures or video of your children may be used in marketing materials for the preschool, educational trainings, notice of events open to the public (e.g. annual fundraiser or Family Fun Day), or on the ALG website. In no instances will your child's last name be used to identify him/her.

Personal Information: ALG shares family information within the school community to allow families to contact each other directly. ALG does NOT share this information with any third party entities unless you provide written consent asking us to share specific information about you or your child (e.g., to an elementary school or health organization). ALG follows technology recommendations to keep this data safe and secure, but realize that there is always a small risk on the internet.
